OVERVIEW

Protect Your Travel Investment and Yourself!

The Village Travel Protection Plan can help protect your travel investment, your belongings, and most importantly, you for unforeseen circumstances that may arise before or during your trip.

HOW THE PLAN WORKS

The Village Travel Protection Plan is made up of two different components. Part A Cancellation Waiver (non-insurance) is provided by Village Travel, Part B consists of Travel Insurance provided by United States Fire Insurance Company and Non-Insurance Assistance Services provided by Robin Assist, LLC.

- Part A – Part A of your Protection Plan offers the Village Travel Cancellation Waiver. This allows you to cancel your Village Travel travel arrangements for any reason up to the day before the scheduled trip departure for a specified reason or up to two (2) business days before the scheduled trip departure for any reason not specified, we will waive our corresponding cancellation penalties and reimburse you in cash or in travel vouchers. (Depending on your reason for cancellation) for the non-refundable portion of the trip cost.
Please Note: This waiver does not cover fees or costs associated with any transportation, accommodations, or other travel services that are not arranged by us. Any amount payable under this waiver will be reduced by the amount of any Trip Cancellation amounts paid or payable under any other travel insurance or travel protection plan providing Trip Cancellation benefits.
- The Cancellation Waiver of this Part A are not insurance benefits and are not underwritten by United States Fire Insurance Company. They are provided by Village Travel.
- Part B – Travel Insurance provided by United States Fire Insurance Company, administered by battleface Insurance Services, LLC
- Non-Insurance Assistance Services provided by Robin Assist, LLC

PART A - VILLAGE TRAVEL CANCELLATION WAIVER (NON-INSURANCE)

The Village Travel Cancellation Waiver allows participants additional flexibility if plans change.

- Cancel up to the day prior to scheduled departure for a specified reason and receive cash reimbursement
- Cancel up to two (2) business days prior to scheduled departure for any reason not otherwise specified and receive reimbursement in the form of Village Travel vouchers

This waiver is provided by Village Travel, is not insurance, and is not underwritten by United States Fire Insurance Company.

This plan is not available to New York residents

PART B - TRAVEL PROTECTION (UNDERWRITTEN BY UNITED STATES FIRE INSURANCE COMPANY)

Travel Protection included in this plan provides coverage for certain covered events, subject to terms, conditions, limitations and exclusions.

KEY PROTECTION BENEFITS INCLUDE

- Trip Interruption – up to 125% of non-refundable insured trip cost
- Trip Delay 12 hours – up to \$2,000 (\$200 per day)
- Accident & Sickness Medical Expense – up to \$25,000
- Medical Evacuation & Repatriation of Remains – up to \$250,000
- Baggage & Personal Effects – up to \$1,000 subject to per item maximum of \$300
- Baggage Delay 12 hours – up to \$300
- Missed Connection 3 hours – \$500
- 24-Hour Accidental Death & Dismemberment – \$25,000

IMPORTANT NOTES

- Trip Interruption benefits are payable only for covered reasons.
- Coverage is subject to exclusions, limitations and applicable deductibles.
- The Pre-Existing Medical Condition Exclusion Waiver is available provided the cost of the plan is received within 14 days of the date your initial payment or deposit for your trip is received and you are medically able to travel and not disabled at the time your plan cost is paid Insurance coverage is excess of other valid and collectible insurance except Medical Evacuation coverage.
